Costs of Sales

During the third quarter of 2019, the company had cost of sales of 12.67 million baht, a decrease of 3.72 million baht or by 22.68 % from the same quarter of 2018 due to a decrease of the company's revenue.

Selling and Administrative Expenses

During the third quarter of 2019, the Company has incurred total administrative expenses of 18.53 million Baht, decreased by 7.00% and total selling expenses of 15.15 million Baht, decreased by 44.57% from the same period of 2018 due to a decrease of the company's revenue.

Net Profit

Net profit of the company's operation for the quarter ended September 30, 2019 when comparing with the same quarter ended September 30, 2018 decreased from net profit in amount of 25.09 million baht to net profit in amount of 14.87 million baht or decreased 10.22 million baht or decreased by 40.73% because the reasons described above.
