Costs of Sales

During the second quarter of 2020, the company had cost of sales of 11.65 million baht, decreasing 2.14 million

baht or a decrease of 15.49 % from the same quarter of 2019.

Selling and Administrative Expenses

During the second quarter of 2020, the Company incurred total administrative expenses of 17.96 million Baht, a

decrease of 16.95% and total selling expenses of 9.94 million Baht, an increase of 6.20% from the same period of 2019 due to

an adjustment of the company's marketing plan.

Net Profit

Net profit of the company's operation for the quarter ended June 30, 2020 when compared with the same quarter

ended June 30, 2019 increased from net profit of 11.62 million baht to net profit of 19.25 million baht, an increase of 7.63

million baht or 65.69% because of the reasons described above.
