Costs of Sales

During the first quarter of 2023, the company had cost of sales of 15.02 million baht, an increase of 4.04 million

baht or an increase of 36.78% from the same quarter of 2022 due to an increase in the company's revenue.

Selling and Administrative Expenses

During the first quarter of 2023, the Company incurred total administrative expenses of 16.10 million baht,

a decrease of 9.55% and total selling expenses of 13.84 million baht, an increase of 38.89% from the same quarter of 2022,

Net Profit
